Dear Avoca Parents/Guardians:

School bus transportation is furnished free to all children living one and one-half (1-1/2) miles or more from the school they are attending.

The fees for children living less than one and one-half (1-1/2) miles from school for the two-way service are:

First rider in family.....\$500.00 per year
Second rider in family.....\$400.00 per year
Each additional rider in family.....\$350.00 per year
(Not to exceed \$1400 per family)

There is a \$50 discount per family if payment is received by June 30, 2011.

We also offer a one-way bus service option. You will need to designate either a pick up (a.m.) or drop off (p.m.) for your one-way selection. You may not alternate between pick up (a.m.) and drop off (p.m.). **If your service needs vary, you must select the two-way bus service.** The fees for children living less than one and one-half (1-1/2) miles from school for one-way service are:

First rider in family.....\$275.00 per year
Second rider in family.....\$225.00 per year
Third rider in family.....\$200.00 per year
Fourth rider in family.....\$200.00 per year
Each additional rider in family.....\$175.00 per year

There is a \$50 discount per family if payment is received by June 30, 2011.

You can pay your bus fee by cash, check payable to Avoca School District No. 37 or credit card. Please complete the attached form (both sides) indicating your name, you child(ren)'s name, the type of service you need and your payment method. Credit card payments can be made using the enclosed form or online at the Avoca Web Store. You can access the Avoca Web Store by clicking on the Parents and Community Link at the district's web page at www.avoca37.org. Then you need to click on the \$Web Store icon to make your payment. There are two payment options for bus fees. The first is a single payment made by June 30th, 2011. The second is a two payment plan with half due by June 30, 2011 and half due by November 1, 2011. Those wanting to take advantage of the two payment plan will have to either submit two checks, one dated on or before June 30, 2011 and one dated November 1, 2011 or give the district permission to charge the second half of the payment due on November 1, 2011. The Avoca Web Store can only be used for the single payment option.

In order to plan for the 2011-12 transportation needs, the information on the top half of the "Avoca Schools Bus Permit Card" must be returned no later than June 30, 2011. Fill out one bus permit card for **each** child in your family. **Your child will not be routed for bus service unless a completed bus permit card has been received by Jackie.** The completed school bus permit card, bus fee payment form and the applicable payment must be returned in the envelope provided by June 30, 2011. If your child rode the bus this year but will not be taking the bus next year, please let Jackie know as soon as possible. Routes and schedules will be mailed the week of August 8th to families who have sent in their bus permit card and payment (if applicable).
